LPC State Mandate

The primary mission of the LPCs is to plan for child care and development services (serving children ages 0-12) based on the needs of families in the local community. LPCs are intended to serve as a forum to address the child care needs of all families in the community for all types of child care, both subsidized and non-subsidized. There are currently LPCs representing each county in California.

See Education Code, Chapter 2.3, Article 1, Section 8499 and Article 2, Sections 8499.3, 8499.5 and 8499.7.



Membership & Funding of LPCs Education Code 8499.3-8499.7

- (a) It is the intent of the Legislature that local child care and development planning councils shall provide a forum for the identification of local priorities for child care and the development of policies to meet the needs identified within those priorities.
- (b) The county board of supervisors and the county superintendent of schools shall do both of the following:
 - (1) Select the members of the local planning council. Before making selections pursuant to this subdivision, the board of supervisors and the county superintendent of schools shall publicize their intention to select the members and shall invite local organizations to submit nominations. In counties in which the superintendent is appointed by the county board of education, the county board of education may make the appointment or may delegate that responsibility to the superintendent.



Membership & Funding of LPCs Education Code 8499.3-8499.7

- (2) Establish the term of appointment for the members of the local planning council.
 - (c) (1) The local planning council shall be comprised as follows:
 - 20% of the membership shall be consumers.
 - 20% of the membership shall be child care providers, reflective of the range of child care providers in the county.
 - 20% of the membership shall be public agency representatives.
 - 20% of the membership shall be community representatives, who shall not be child care providers or agencies that contract with the department to provide child care and development services.
 - The remaining 20% shall be appointed at the discretion of the appointing agencies.



Membership & Funding of LPCs Education Code 8499.3-8499.7

- (f) Upon establishment of a local planning council, the local planning council shall elect a chair and select a staff.
- (g) Each local planning council shall develop and implement a training plan to provide increased efficiency, productivity, and facilitation of local planning council meetings. This may include developing a training manual, hiring facilitators, and identifying strategies to meet the objectives of the council.
- (h) No member of a local planning council shall participate in a vote if he or she has a proprietary interest in the outcome of the matter being voted upon.

The Proposal

The proposal for Council vote, is to shift fiscal agency of SLO County Child Care Planning Council from CAPSLO to SLOCOE with the offer for SLOCOE to fund the Council Infrastructure from the general fund.



The Proposal

What Would **NOT** Change:

- State mandates of the Council
- Council membership and operations
- Council representation in the community
- Council staff still reports to the Council and Executive Committee
- Council remains the Quality Counts Consortia Lead
- Quality Counts operation under the direction of the local Consortium



The Proposal

What Would Change:

- Council staff position funded by SLOCOE General Fund
 - Establishing the position and foundational, local investment of LPC (separate from State funding)
- Shift of personnel into SLOCOE HR Structure
 - Titles and Salary Range
- Ability to draw down State funding to support SLO County's mixed delivery system
- Stronger link to advocate for SLO County's mixed delivery system with LEAs
- For Quality Counts elimination of multiple subcontracts from SLOCOE to CAPSLO CCPC
